Pursuant to the Executive Orders, and to maintain the orderly conduct of the meeting, the California Public Finance Authority will allow the Board of Directors, staff and interested members of the public to attend the meeting telephonically or by the Internet, and to participate in the meeting to the same extent as if they were present in the Board's Chambers. Members of the public who choose to attend the meeting virtually, using certain digital or landline phones, may listen to the audio broadcast of the meeting, but will not be able to comment during the meeting. a. Consideration of approving an amendment to the GPM Municipal Advisors, LLC services agreement.

#### AMENDMENT NO. 2 TO SERVICES AGREEMENT

This **AMENDMENT NO. 2 TO SERVICES AGREEMENT** (this "<u>Amendment</u>"), dated as of February 23, 2021, is entered into by and between GPM Municipal Advisors, LLC, a California limited liability company ("GPM"), HB Bond Administration 1987, LLC, a California limited liability company ("HB"), Compliance Services, LLC, a California limited liability company ("Compliance Services") and California Public Finance Authority, a California joint powers authority (the "<u>Authority</u>"). All capitalized terms used but not defined herein have the meanings associated with such terms in the Services Agreement (as defined below).

**WHEREAS**, GPM, HB, Compliance Services and the Authority entered into that certain Services Agreement dated as of July 7, 2015, as amended by the First Amendment to Services Agreement entered into as of September 1, 2015 (collectively the "Services Agreement"); and

**WHEREAS**, pursuant to Section 15.14 of the Services Agreement, the Services Agreement may be amended only by an agreement in writing signed by GPM, HB, Compliance Services and the Authority; and

**WHEREAS**, the parties wish to amend the Services Agreement to clarify the effect of the First Amendment to Services Agreement, remove HB from any obligation or benefit of the Services Agreement, and reflect a change in Exhibit C, GPM/Authority Fees of the Services Agreement as set forth below.

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements set forth in this Amendment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- **1.** Clarification to First Amendment to Services Agreement. Notwithstanding any provision of the First Amendment to Services Agreement to the contrary, any and all references to "HB" in Section 2 of the First Amendment to Services Agreement shall be changed to "GPM".
- 2. Removal of HB. HB hereby assign all of their respective right, title and interest in and to the Services Agreement to GPM and Compliance Services and GPM and Compliance Services hereby accepts such assignment effective February 28, 2019. In accepting such assignment, GPM and Compliance Services hereby assumes all liabilities and responsibilities of HB thereunder, whether now existing, known or unknown. This Amendment shall effectuate a complete release and removal of HB from the Services Agreement.
- **3.** Amendment Provisions. Effective as of execution of the Services Agreement by and between GPM, Compliance Services, and the California Community Housing Agency dated February 5, 2019, Item 2 of Exhibit C of the Services Agreement is hereby amended as follows:

Replacing the term "Ten Thousand Dollars (\$10,000)" in Item 2 with "Five Thousand Five Hundred Dollars (\$5,500)" such that the annual fee for GPM's

provision of Municipal Advisory Services (the Municipal Advisory Fees) is decreased from \$10,000 to \$5,500.

- 4. <u>Continued Validity of the Services Agreement</u>. Except as expressly provided in this Amendment, each of the terms and provisions of the Services Agreement shall remain in full force and effect in accordance with their respective terms. The amendment set forth herein is limited precisely as written and shall not be deemed to be an amendment or waiver to any other term or condition of the Services Agreement or any of the documents referred to therein. From and after the date of this Amendment, all references in the Services Agreement to "Agreement" and all references in any of the Exhibits in the Services Agreement shall be deemed to be references to the Services Agreement, as amended hereby.
- 5. <u>Due Authority</u>. GPM, HB and Compliance Services each separately represents and warrants that it has taken all corporate action necessary to enter into this Amendment, the individual signing this Amendment below on behalf of GPM, HB and Compliance Services is authorized to so sign and this Amendment represents a valid and binding obligation on the part of GPM, HB and Compliance Services.
- **6.** Parties in Interest. This Amendment shall be binding upon and shall inure to the benefit of the parties to this Amendment and to the Services Agreement and their respective successors and permitted assigns.
- 7. <u>Counterparts</u>. This Amendment may be executed in counterparts, each of which shall be deemed an original but all of which shall constitute one and the same instrument. Facsimile counterparts, including facsimile counterparts delivered in .pdf or other electronic format, shall be acceptable and binding and treated in all respects as having the same effect as an original counterpart.
- **8.** Governing Law. The interpretation of this Amendment shall be governed by the substantive laws of the State of California, excluding its conflict of laws rules.
